Capital Region 2017: Summary

The smoking rate is slightly lower at 13.5% in 2017 compared to 14% in 2015. Moreover, the smoking rate is greatest in the Capital Region among those earning less than \$50,000 per year per household.

Smoking Behavior

- Forty-six percent of Albany County residents reported having smoked at least 100 cigarettes in their life.
 - Only 26% of those 18-29 have ever smoked.
- Twenty-four percent of residents said they smoke every day while 6% smoke some days.
 - Current smoking rates are greatest among those earning less than \$50,000 (24%).
- Twenty-five percent Capital Region residents have ever tried using an E-cigarette.
 - 49%, almost half of all respondents, in the 18-29 year old age group in the Capital Region said that they have tried using an electronic cigarette or vaping product at least once.
 - People with less than a college degree are twice as likely to have tried Ecigarettes as those with a college degree (34% vs. 17%).
- In the Capital Region, one out of ten people vape at least some days. Schenectady County stands out with one out of four people using e-cigarettes or vaping at least some days, with 13% of those reporting using e-cigarettes every day.
 - Fifteen percent of Capital Region residents who have never smoked have tried using an e-cigarette.

Display and Sale of Tobacco Products

- Asked whether they think pharmacies should or should not sell tobacco products, a majority of all citizens (69%) think tobacco products should not be sold in pharmacies.
- Fifty-six (41% strongly in favor) percent of all residents are in favor of a regulation that would ban the sale of all tobacco products in pharmacies.
- Three-quarters (75%), up 9 points from 2015, of all Capital Region residents and 63 percent of smokers, think that tobacco products should not be sold in stores that are located near schools.
- A majority (59%) support a regulation that would prohibit the sale of tobacco products in stores that are located near schools. A plurality of smokers support this potential regulation with 45 percent supporting it and 36 percent opposed.
- Forty-one percent of all residents are in favor of a regulation that would limit the number of stores that could sell tobacco in their community while 33 percent oppose

- that regulation. Smokers oppose the limitation of stores by 54 to 29 percent. Of those that have never smoked, this regulation is favored by 48 to 24 percent.
- Nearly three-fourths (70%) of Capital Region residents have over the past 30 days noticed packs of cigarettes or cigars visible behind the cash register or in other areas of stores at least occasionally.
- 34% favor while 37% are against a regulation that would prevent retailers from accepting coupons that reduce the price of cigarettes.
- Similarly, 33 percent are in favor while 38 percent are against, a regulation that would prevent retailers from offering multi-pack discounts on cigarettes.

Attitudes towards Teen Smoking

- Sixty-three percent of all residents, but only 53 percent of smokers, think teen smoking
 is a significant problem in their community. This is a 10 point decline from 2015 for
 both residents and those who smoke.
- Majority (56%) of all residents, but only 46 percent of smokers, think teen use of ecigarettes, vaping or vape pens is a significant problem in their community.
- Majorities agree that:
 - In-store advertising make teens more likely to smoke (56%).
 - Seeing actors smoking in the movies encourages smoking among teens (62%).
 - Movies with a youth rating of G, PG, or PG13 should not include tobacco use or imagery (64%).

Methods and Nature of the Sample

Using random digit-dialing (RDD) interviews were conducted with 1,051 residents of the Capital Region. Of those, 462 were conducted via cell phone. Completed interviews from both landline and cell phones calls were merged and weighted by known age and gender characteristics so as to enhance representativeness.

Data is reported with a margin of error of +/- 3.0 percentage points at the 95% confidence level having included the design effect of weighting on that margin of error.










Q2: For each of the following policies that would prohibit certain behaviors in public places, tell me whether you are in favor of or if you are against prohibiting the behavior





Albany County 2017: Summary

The current rate of smoking is up slightly in Albany County in 2017 when compared to 2015. However, a strong majority of Albany County residents support more restrictive regulation of the availability and display of tobacco products.

Smoking Behavior

- 46% of Albany County residents have smoked at least 100 cigarettes in their life.
- Today 13% of Albany residents smoke. 23% of those current smokers smoke every day, while 4% of all citizens smoke on some days.
- 28% of residents have ever tried using an E-cigarette and 3% of those residents use them every day.

Display and Sale of Tobacco Products

- 75% of county residents think that tobacco products should not be sold in stores that are located near schools.
- 59% are in favor of a regulation that would prohibit the sale of tobacco products in stores that are located near schools with 42% strongly in favor. Over one-third of smokers support this potential regulation with 39% supporting it and 26% opposed.
- 42% of all residents are in favor of a regulation that would limit the number of stores
 that could sell tobacco in their community while 33% oppose that regulation 29% of
 those who currently smoke are in favor of a regulation that would limit the number of
 stores that could sell tobacco while 49% of those that have *never* smoked are in favor of
 this regulation.
- 58%, down from 65% in 2015, of all residents are in favor of a regulation that would prohibit the sale of all tobacco products in pharmacies.
- 68% of county residents (up significantly from 54% in 2015) have over the past 30 days noticed packs of cigarettes or cigars visible behind the cash register or in other areas of stores at least occasionally.
- 29% of residents favor while 40% are against a regulation that would prevent retailers from accepting coupons that reduce the price of cigarettes.
- Similarly, 28% of residents are in favor while 42% are against a regulation that would prevent retailers from offering multi-pack discounts on cigarettes.

Attitudes towards Teen Smoking

- 61% of Albany County residents in 2017, down from 74% in 2015, think teen smoking is a significant problem in their community, while 47% of current smokers say the same.
- Majorities agree that:
 - o In-store advertising make teens more likely to smoke (53%).
 - Seeing actors smoking in the movies encourages smoking among teens (65%).
 - 53% think that vaping is a problem for teens, close in number to the 61% who think smoking is a problem for teens in their community.

Methods and Nature of the Sample

Using random digit-dialing (RDD) interviews were conducted with 350 residents of Albany County. Completed interviews from both landline and cell phones calls were merged and weighted by known age and gender characteristics so as to enhance representativeness.

Data is reported with a margin of error of +/- 5.2 percentage points at the 95% confidence level having included the design effect of weighting on that margin of error.







Q14: Have you ever tried using an Electronic Cigarette or E-cigarette, even just one time?




Q15: Do you now use e-cigarettes, or other vaping products?






Q8: What is your opinion about a regulation that would prohibit the sale of all tobacco products in pharmacies?




Q4: What is your opinion about a regulation that would limit the number of stores that could sell tobacco in your community?



Q5: In your opinion, do you think tobacco products should or should not be sold in stores that are located near schools?







Q9: What is your opinion about a regulation that would prevent retailers from accepting coupons that reduce the price of cigarettes?




Q10: What is your opinion about a regulation that would prevent retailers from offering multipack discounts on cigarettes, such as 2 packs for the price of 1?







Schenectady County 2017: Summary

The current rate of smoking is down in Schenectady County in 2017 when compared to 2015, and a majority of residents agree that in-store advertising and seeing actors smoke encourage teens to smoke.

Smoking Behavior

- 43% of Schenectady County residents have smoked at least 100 cigarettes in their life.
- Today 14% of Schenectady residents smoke. Of those, 24% smoke every day, while 7% smoke on some days.
- 19% of residents have ever tried using an E-cigarette and 24% of those are current users.

Display and Sale of Tobacco Products

- 78% of all county residents and 73% of smokers think that tobacco products should not be sold in stores that are located near schools.
- 63% support a regulation that would prohibit the sale of tobacco products in stores that are located near schools. 48% of smokers favor this potential regulation while 43% are against it.
- 40% of all residents are in favor of a regulation that would limit the number of stores
 that could sell tobacco in their community while 32% oppose that regulation. 25% of
 smokers favor the limitation of stores while 46% of those that have never smoked are in
 favor.
- 61%, up from 58% in 2015, of all residents are in favor of a regulation that would prohibit the sale of all tobacco products in pharmacies. Among current smokers, 46% are in favor while 31% are against this regulation.
- 67% of county residents (up significantly from 57% in 2015) have over the past 30 days noticed packs of cigarettes or cigars visible behind the cash register or in other areas of stores at least occasionally.
- 42% of residents favor, while 32% are against, a regulation that would prevent retailers from accepting coupons that reduce the price of cigarettes.
- Similarly, 40% of residents are in favor, while 35% are against, a regulation that would prevent retailers from offering multi-pack discounts on cigarettes.

Attitudes towards Teen Smoking

- 63% of Schenectady County residents in 2017, down from 73% in 2015, think teen smoking is a significant problem in their community, while 46% of current smokers say the same.
- Majorities agree that:
 - In-store advertising make teens more likely to smoke (57%).
 - Seeing actors smoking in the movies encourages smoking among teens (60%).
- 59% agree that teen use of e-cigarettes is a significant problem in their community.

Methods and Nature of the Sample

Using random digit-dialing (RDD) interviews were conducted with 351 residents of Schenectady County. Completed interviews from both landline and cell phones calls were merged and weighted by known age and gender characteristics so as to enhance representativeness.

Data is reported with a margin of error of +/- 5.2 percentage points at the 95% confidence level having included the design effect of weighting on that margin of error.







Q14: Have you ever tried using an Electronic Cigarette or E-cigarette, even just one time?




Q15: Do you now use e-cigarettes every day, some days or not at all?








Q10: What is your opinion about a regulation that would prevent retailers from offering multipack discounts on cigarettes, such as 2 packs for the price of 1?







Rensselaer County 2017: Summary

The current rate of smoking is down slightly in Rensselaer County in 2017 when compared to 2015. However, citizens have noticed packs of cigarettes or cigars visible in stores significantly more frequently compared to 2015.

Smoking Behavior

- 46% of Rensselaer County residents have smoked at least 100 cigarettes in their life.
- Today 15% of Rensselaer residents smoke. 27% of those smoke everyday while 6% smoke on some days.
- 26% of residents have ever tried using an E-cigarette and 1% of those respondents are current users.

Display and Sale of Tobacco Products

- 71% of all county residents and 55% of smokers think that tobacco products should not be sold in stores that are located near schools.
- 54% support a regulation that would prohibit the sale of tobacco products in stores that are located near schools. 54% of smokers favor this potential regulation while 41% are against it.
- 42% of all residents are in favor of a regulation that would limit the number of stores
 that could sell tobacco in their community while 33% oppose this regulation. 27% of
 smokers support the limitation of stores while 49%% of those that have never smoked
 are in favor of this regulation.
- 52%, down from 58% in 2015, of all residents are in favor of a regulation that would prohibit the sale of all tobacco products in pharmacies.
- 72% of county residents (up significantly from 63% in 2015) have over the past 30 days noticed packs of cigarettes or cigars visible behind the cash register or in other areas of stores at least occasionally.
- 38% of residents favor while 35% are against a regulation that would prevent retailers from accepting coupons that reduce the price of cigarettes.
- Similarly, 38% of residents are in favor while 32% are against a regulation that would prevent retailers from offering multi-pack discounts on cigarettes.

Attitudes towards Teen Smoking

- 66% of Rensselaer County residents in 2017, down from 73% in 2015, think teen smoking is a significant problem in their community, while 68% of current smokers say the same.
- Majorities agree that:
 - o In-store advertising make teens more likely to smoke (60%).
 - Seeing actors smoking in the movies encourages smoking among teens (62%).

Methods and Nature of the Sample

Using random digit-dialing (RDD) interviews were conducted with 350 residents of Rensselaer County. Completed interviews from both landline and cell phones calls were merged and weighted by known age and gender characteristics so as to enhance representativeness.

Data is reported with a margin of error of +/- 5.2 percentage points at the 95% confidence level having included the design effect of weighting on that margin of error.







Q15: Have you ever tried using an Electronic Cigarette or E-cigarette, even just one time?




Q16: Do you now use e-cigarettes every day, some days or not at all?






Q8: What is your opinion about a regulation that would prohibit the sale of all tobacco products in pharmacies?




Q4: What is your opinion about a regulation that would limit the number of stores that could sell tobacco in your community?



Q5: In your opinion, do you think tobacco products should or should not be sold in stores that are located near schools?








Q9: What is your opinion about a regulation that would prevent retailers from accepting coupons that reduce the price of cigarettes?



Q10: What is your opinion about a regulation that would prevent retailers from offering multipack discounts on cigarettes, such as 2 packs for the price of 1?




Q11: What is your opinion about a policy that would require people to be 21 years old before they could purchase cigarettes and other tobacco products?




Q2A. What is your opinion about policies that prohibit smoking in outdoor public places such as beaches or parks?




Q2B. What is your opinion about policies that prohibit smoking in entrance ways of public buildings and workplaces?
